


New Castle Emergency Preparedness

Wildfire season in Colorado can affect us all. If a fire or other emergency should require evacuation of town residents, it is important to know what to do. Please note that following instructions from law enforcement/traffic control personnel is critical to not only your safety but that of others. Please heed their guidance in an emergency.

The first step is preparedness. 1) Sign up for emergency notification at www.garco911.org. 2) Make an emergency contact list for everyone in your home to carry and designate a place to meet. 3) Prepare a go bag for everyone in the home. Make sure that this is prepared ahead of an emergency. 4) Be aware of all the exits from town, highlighted on the map below. 5) Plan to attend *Firewise: Ready, Set, Go* presented Colorado River Fire Rescue at CMC Rifle on May 28th from 10:00 am – 3:00 pm. May 7 is a Full Day in New Castle

Saturday, May 7, kicks off with the **Hogback Hustle**. The 5K race starts at the City Market parking lot at 9:00 am, then snakes through town and ends at Burning Mountain Park with breakfast and awards. The cost is \$35, benefitting the New Castle Recreation Department and the Youth Scholarship Program. Also on May 7 is the annual **Youth Fishing Derby** presented by the New Castle Cub Scouts. Everyone is asked to pre-register at newcastlerec.com, then arrive at Alder Park Pond promptly at 9:30 am to check in. This free event requires a brief "Learn to Fish" lesson that must be taken before fishing begins. Fishing in age groups will be staggered between 9:30 am and 2:00 pm. Thanks to Wendy's, everyone who registers will receive a free frosty. Grease Monkey is a Gold Sponsor this year.

May 7 is the date for the **Annual Town-Wide Yard Sale** beginning at 8:00 am. Participants are asked to put up and remove their own yard sale signs. Everyone is also asked to be patient with the increased traffic through town. Note that all traffic will be halted on Castle Valley Boulevard, Midland Avenue, 7th Street and Main Street between 9:00 am and 10:00 am for the Hogback Hustle.

Finally, **Symphony in the Valley** returns to present "Symphony Swing" on Saturday, May 7, at 6:30 pm at New Hope Church. The concert is the Symphony's annual fundraiser and features Big Band music from the Roaring Twenties, with dancing and dinner catered by Stoney Joanie's.

New Castle Fire Restrictions in Effect

New Castle's Historic Preservation Commission Subgrant Award for 2022

The Town's Historic Preservation Commission is a member of the state's Certified Local Government program through History Colorado. This program provides opportunities and resources to local municipal historic commissions, including subgrants for historic surveys.

The New Castle Historic Preservation Commission and Commission Clerk Remi Bordelon applied for a grant in late 2021 to fund a historic survey of Main Street and other designated properties. The grant application was approved for survey work to be completed this year.

This opportunity affords the commission the ability to review properties for historic designation as well as to update the town's original 1996 survey.

New Castle's April 5 Election Results

At New Castle's April 5, 2022, regular election, Mayor Art Riddile was re-elected, and Bruce Leland, Brandy Copeland and Caitlin Carey were elected to Town Council seats. All were sworn in at the April 19 Town Council Meeting. Outgoing Council Member Scott Owens was thanked for his contributions to the town as his term expired.

Ballot Issue A, the lodging tax, passed, increasing the town lodging tax on hotel/motel and VRBO/Air B-n-B type rooms from 2.5% to 5% beginning in January 2023. New Castle has 3,037 registered voters. 730 ballots were cast which equals a 24.04% voter turnout.

Designated Election Official, Town Clerk Melody Harrison, Deputy Town Clerk Mindy Andis and Administrative Assistant Remi Bordelon began preparing for the election in December 2021 in accordance with state election law. Six election judges were selected and trained and they began the process of signature verification in late March. Two employees from the Garfield County Elections office assisted and used counting machines that electronically scanned the ballots and counted the votes.

New in New Castle: Wrap and Roll Deli

A new resident of New Castle, Anabel has been wanting to open her own deli for years. We will only serve homemade bread for your sandwiches, made from scratch pastries, croissants, bagels, muffins, cinnamon rolls, and at some point homemade soups. Wrap and Roll Deli also has ice cream, fruit smoothies made with real fruit juice as well as espresso and lattes. Please stop by and give us a try. We promise you won't be disappointed."
