Lions Club Turkey Dinner Returns

For the past two years the New Castle Lions Club has served Thanksgiving dinners to go to residents driving through the Community Center parking lot. Covid restrictions in 2020 made gathering inside to eat impossible, and in 2021 the club decided to be cautious and again canceled the sit-down dinner. The club's ability to provide the take-out dinners was cited in their 2021 Volunteer Organization of the Year award.

The Lions are happy to announce that on November 19, the free community meal will again be served indoors in the Community Center, beginning at 5:00. The Lions will provide turkey, ham, dressing, potatoes and gravy. Guests are invited to bring a vegetable, salad or dessert to share. The Lions will again use the occasion to collect non-perishable food items for Lift-Up.

The Lions Club meets on the second Tuesday of each month, at 6:30 at First Baptist Church. Anyone interested in volunteering with the Lions is invited to attend. Besides serving the annual turkey dinner, the Lions Club collects used glasses for re-use, provides eye care for income-eligible residents, maintains a section of I-70, rings bells for the Salvation Army, and assists with town events.



New Castle Says Farewell to the 88 Grill

On October 1, John and Cori Webber announced that after 23 years, they would close the 88 Grill, their popular Main Street restaurant. They opened the Elk Creek Mining Company in the historic Barry Building in 1999, and later renamed it 88 Grill in honor of New Castle's 1888 founding date.

While best known for its food, the restaurant also featured a welcoming atmosphere and attentive staff. In addition, the restaurant was known as a supporter of local events, schools and charities. The Webbers donated gift certificates or profits from dinners to many organizations. In recognition of their contributions to the town, the Town Council read a proclamation at their October 18th meeting thanking the restaurant and declaring John and Cori Webber to be honorary citizen of the town.

Fortunately, the Webbers will remain a presence on Main Street as owners and operators of the Ore House hotel. They plan to add the 1892 Suite with custom-built bunk beds in half of the first-floor space. The rest of the floor will see the return of the much-loved Speckled Feather store.



Election Day is November 8

It is now too late to return election ballots by mail. They must now be deposited in the ballot kiosk outside Town Hall before 7:00 on Tuesday, November 8. Also on the 8th, an in-person Voter Service and Polling Center will be open from 7:00 am to 7:00 pm in the New Castle Library.

The blue Ballot Information Book was sent to registered voters in October. It contains essential information about each of the ballot issues to be decided this year. Utility Rates for 2021

The annual 3% increase in utility rates will take effect on January 1, billable in February. These rates will enable the town to continue to meet residents' needs while providing a high level of quality and service. The new base rates will be Water Service: \$32.22; Sewer Service: \$58.27; Trash Service: \$34.57.

Senior discounts apply to qualified residents, and there are surcharges for water use above 12,000 gallons. A listing of all the new water, sewer and trash rates will be printed on the back of utility bills.

Garfield County PIO Group Comes to New Castle



On Tuesday, October 25, the Town of New Castle hosted members of the Garfield County Public Information Officer group. Town PIO, Rochelle Firth introduced Terrence Davis from New Castle PD as an additional PIO for the town.

PIO members from across the county gathered in Town Hall for a Zoom meeting with Dionne Waugh and Carrie Haverfield, both PIOs from Boulder County.

Firth had heard both speakers at a PIO conference and invited them to New Castle. Their presentation focused on the shooting of Boulder's Chief of Police, the City Market shooting and the Marshall Fire. They discussed their PIO work during the events and the aftermaths.

"It was very interesting to hear how PIO's from across the state came to help Boulder County. They were able to assist families who did not want the media in their front yards by acting as the liaison for the City Market victims' families. Some wanted to be left alone, while others wanted their stories heard. I am glad that I was able to get Dionne and Carrie to share their story and presentation to our local PIO group," Firth stated.

Volunteer New Castle, a committee of the River Center, announced the Volunteers of the Year at the Burning Mountain Festival in September. Chair Mari Riddile, joined by other committee members, recognized Tom Elder and Mary Johnson as the Volunteers of the Year, New Castle Liquors as the Volunteer Business of the Year and the Cub Scouts as the Volunteer Organization of the Year. Mary Metzger received posthumous Volunteer of the Year recognition.
