RESOLUTION NO. TC 2018-22**

**A RESOLUTION OF THE NEW CASTLE TOWN COUNCIL REGARDING ITS
POSITION ON CERTAIN BALLOT INITIATIVES TO BE DECIDED BY THE
VOTERS AT THE NOVEMBER 6, 2018 ELECTION.**

WHEREAS, there are thirteen state-wide ballot initiatives and five local ballot issues being presented to the voters at the November 6, 2018 election; and

WHEREAS, many of the initiatives will have impact the citizens of the Town of New Castle ("Town"); and

WHEREAS, the Town Council has already adopted a resolution in support of the ballot issue regarding the Roaring Fork Transit Authority mill levy increase; and

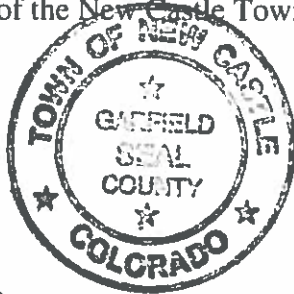
WHEREAS, Town Council now desires to make known its position regarding other initiatives in light of their potential impact on the health, safety, and welfare of the Town and its residents.

NOW, THEREFORE, BE IT RESOLVED BY THE NEW CASTLE TOWN COUNCIL AS FOLLOWS:

1. **Recitals.** The foregoing recitals are incorporated by reference as findings and determinations of the Council.
2. **Statement of Position.** The Town Council takes the positions set forth below regarding the following ballot initiatives to be decided at the November 6, 2018 election:
 - a. **Amendment 74:** The Town Council of the Town of New Castle does not support this ballot issue.
 - b. **Proposition 110:** The Town Council of the Town of New Castle supports this ballot issue.
 - c. **Proposition 112:** The Town Council of the Town of New Castle does not support this ballot issue.
 - d. **Garfield County School District RE 2 Ballot Issue 4A:** The Town Council of the Town of New Castle supports this ballot issue.
 - e. **Garfield County School District RE 2 Ballot Issue 4B:** The Town Council of the Town of New Castle supports this ballot issue.

- f. **Garfield County Public Library District Ballot Issue 6A:** The Town Council of the Town of New Castle supports this ballot issue.
- g. **Colorado Mountain College Local College District Ballot Issue 7D:** The Town Council of the Town of New Castle supports this ballot issue.
- h. **RFTA Property Tax Ballot Issue 7A:** The Town Council of the Town of New Castle supports this ballot issue.
